Email Updates

The timing of communications will align with the stage of construction that your home is at. The stages at which communication will be provided are listed below. 12. **LANDSCAPING COMPLETE (if landscaping was purchased)**

Site Visits

Pacesetter Homes knows seeing the construction of your home is exciting and we provide **TWO** site visits during construction for presale homes: mechanical walkthrough and cabinet walkthrough. Please note that site visits for pre-planned homes are dependent on the stage of the home at time of purchase. Both site visits will occur during office business hours.

Qualico safety procedures must be adhered to during these on-site appointments. These appointments will be initiated by your site superintendent, and they may contact you by phone, text or email.

1. **MECHANICAL WALKTHROUGH** occurs after rough ins are completed

2. **CABINET WALKTHROUGH** occurs after cabinets are installed

Pre-Occupancy appointment is an additional opportunity for you to see your home. Pre – Occupancy is conducted within the last 2 weeks prior to possession, during office business hours, and will be scheduled and conducted by our warranty provider, Service Q.

Please ensure you review all email update communication and attend site visits. These communications are crucial to staying informed during your home build and are considered the key source of information for reference.
