At that time, two different dates will be offered, one week apart from one another, for you to select from.

If you cannot accommodate an in-person appointment on one of the two predetermined dates, you will be provided the following two options to select from, Designer Curated Inspiration Palette or a Virtual Appointment.

- **In-Person Appointment-** (Recommended) This appointment caters to anyone who would like to touch and feel the samples and get the full experience of working with a professional Interior Designer.

Available appointment times are Monday – Friday at 8:45am. 45 minutes will be allocated for a lunch break, and we will wrap up by 4:15pm. Please be aware that you will be required to wear a mask during your appointment.

Please choose one of the 2 appointment options below: (If In-Person Appointment cannot be accommodated)

- **Designer Curated Inspiration Palette** – Our in-house Interior Designers have carefully assembled 4 distinct inspiration palettes, each suited to its own style. You can choose to stay with the included selections or select an upgrade package.
- **Virtual Appointment** - This option is recommended if you live out of town or province. We will schedule a Zoom meeting with you, where our Designer will walk you through each product selection. This allows you to still add your own personal touch but from the comfort of your home. Please keep in mind that the product colors may not be accurate, depending on the resolution of your screen. There will be no opportunity to view your selections in person.

Available times for virtual appointments will be Monday – Friday at 8:45am, and we will wrap up by 4:15pm. Please ensure you have access to a computer/tablet/phone with speakers and a good internet connection.

Please note: With virtual appointments, we will ask that paperwork is finalized and signed-off within the allocated appointment time. Paperwork will be sent through Adobe.

These appointment options and dates cannot be changed. If you miss your appointment the standard Designer Curated Palette “West Coast” will be applied to your home build. You will have up to 7 calendar days from you missed appointment to select an alternate Designer Curated Palette and available palette upgrades from designQ if you so choose.
